



Indemnity Agreement Form – Student

In exchange for being a student of Shugoki Karate Academy, I agree:

- To release Shugoki Karate Academy from all liability for my death, personal injury, psychological trauma, loss or damage (including property damage) arising from participation in or attendance in any training whether caused by negligence of any of the employees or volunteers of Shugoki Karate Academy.
- To indemnify Shugoki Karate Academy from any loss, liability damage or cost they may incur arising out of or related to my attendance at or participation in any training whether caused by negligence of any of the employees or volunteers of Shugoki Karate Academy.
- That Shugoki Karate Academy does not make any warranty implied or expressed that any services will be provided with due care and skill or that any materials in connection with the services will be fit for the purpose for which they are supplied.
- To participate in any training at my own risk and voluntarily assume all risks, both known and unknown even if arising from the negligence of any of the employees or volunteers of Shugoki Karate Academy.
- That this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by any of the employees or volunteers of Shugoki Karate Academy and is intended to be as broad and inclusive as is permitted by law and that if any portion thereof is held invalid, it is agreed that the balance shall notwithstanding, continue in full legal force and effect.

I acknowledge that:

- The risks associated with attending and participating in training include the risk that I may suffer harm as result of:
 - activities such as, including but not limited to negligence on the part of the martial arts / fitness instructors in the performance of their duties, negligence by other members of Shugoki Karate Academy, negligence in the operation of machinery or equipment, and/or premises liability.
 - Acts of violence and other harmful acts (whether intentional or inadvertent) committed by persons attending or participating in any training.
 - The failure or unsuitability of facilities to ensure safety of persons or property at any event.
